Status updates on previous cases...

- William Schuler was sentenced to 10 years for his involvement in several thefts of copper from homes on Westwind Road, Indian Hills Trail, Bow Lane, Club Lane, Overbrook Road, and Lightfoot Road. Daniel Dunn was sentenced to 5 years. Chrystal Stillwell and Roscoe Thompson are scheduled to either plead guilty or be sentenced in March. All four subjects were involved in several similar thefts throughout Jefferson and Oldham counties.
- Joshua Maier is scheduled to plead guilty to a December burglary on Warrior Road. The defendant was arrested on January 5th after returning to the area of the burglary.
- Sean Graham is scheduled to plead guilty relating to three burglaries on Overbrook Road in 2010. The defendant was linked to the burglaries through DNA evidence at all three scenes. He is also charged with other burglaries in Jefferson and Daviess counties.
